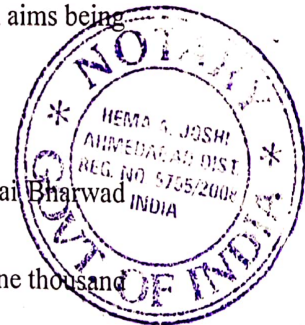

(2) T he settler of this trust namely Shri Gopalbhai Umarbhai Bharwad from his property the sum of Rs. 1001/- In words rupees one thousand and one only kept separate and donated to the trust and from now on ward upon this amount he or his family guardians, heir will not have any rights or authority and that will be considered the property of trust only. And that being accepted by the second party and that they have



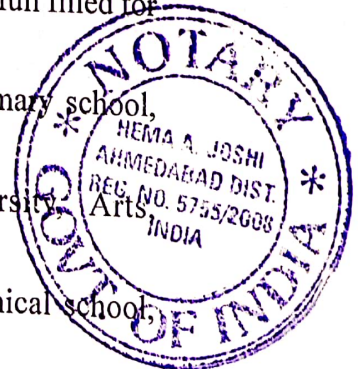
made their seal and signature.

- (3) The trust which being established by this trust deed its name, aims and to appoint the successor trustees and to full fill the aims of the trust that terms, conditions rules and regulations are as under :-

- (A) Name of this trust is : **Dwarkesh Education & Charitable Trust.**
- (B) Jurisdiction : All Over India.
- (C) Office of trust : 145, Bharwad Vas, At Odaki, Ta. Mandal,
Dist. Ahmedabad.

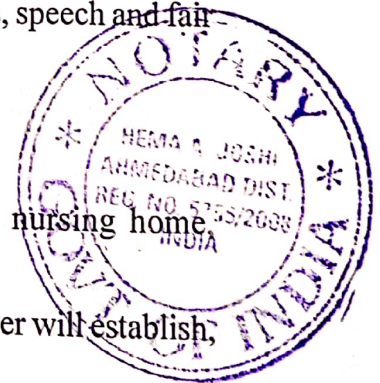
- (4) Aims :

- 1 This trust the Gujarat State and In Country of India living persons for their benefit and welfare will being active for ever.
- 2 This trust without prejudice of Caste, race, higher. Lower, rich, poor, religion, caste, or any difference for each person of their benefit being executed.
- 3 This trust the high quality of education by adopting the same will do all the activities of education.
- 4 This trust each of the person the high value of character be full filled for that spreading of knowledge Balwadi, Anganwadi, Primary school, Secondary School, Higher Secondary School, University, Arts, Commerce, Science colleges, P.T.C. B.ed college, Technical school.



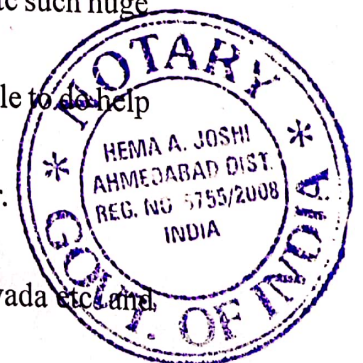
medical college, pharmacy college, Aryurvedic college, for old person education etc and Ghodiagar, Night classes and Adhyapan Mandir, Kumar - Kanya Chhatralaya, Ashram Shala, Uttarbuniyadi Ashram Shala etc to establish, to run and to maintain the same.

- 5 To encourage the student for taking education and to spread the education that to give books and scholarship to student, and those who desirous higher education to give help to them without cost, and within the limitation of trust to do all activities of education.
- 6 For development of student with all respect to establish library, to run and to maintain, and Magazine and such related activities to be made.
- 7 On base of trust Annakshretra to establish, to construct the same and poor and middle class of people to provide food to them, and such related other activities to be made.
- 8 This trust for spreading knowledge Gyansibir, Lectures, speech and fair that will arrange.
- 9 For general health of people of society, hospital, nursing home consulting room, laboratory, health center, research center will establish, to run and maintain and will give help doing such activities. And will provide ambulance van to the people within the limitation of trust.
- 10 For precaution of general health of people the new diseases their



symbolism, their remedy, precaution, that information will be given by arranging camp, lectures and movement for aware of people that different programs will arrange within limitation of trust.

- 11 The student who are from backward class and financial poor, for benefit of them disease cure camp, such program will arrange.
- 12 Medical check up, blood bank, donation camp, eye donation camp, the middle class of people for precaution of their health by physically and mentally that program will arrange and will be helpful to such people.
- 13 Old age persons, blind, deaf, dumb, and physically disable persons for them ashram will establish, and will do administration of the same.
- 14 Within the limitation of trust the deaf and dumb animals like cow, buffalo, grass, mine, medicine and cattle feeding will be made and will maintain gaushala.
- 15 Natural calamity like fire, heavy rain, earth quake, famine etc such huge damage of human lives, on such occasion the effected people to do help to them and as being trust on that base some duties to offer.
- 16 To give service to animal and birds and for them well, havada etc and to arrange water and mine -and corn for those.
- 17 For cow grass, mine, for birds corn, water, medicine etc to be arranged.
- 18 Birds and animal for their medical treatment to open Animal medical



check up centers, and for treatment of animal and birds that medicine is to be provided.

19 Poor and financial weak families for their student, for education scholarship, free books, and note books will be provided.

20 To youth boys and girls that bad customs, bad addicts for awareness of the same that will remove, and to make free that guide lines will be provided.

21 Environment, plantation activities, and such related other activities will be made.

22 All the other activities related to above aims that will be made thereon.

(5) No. of Trustees :

In this trust minimum of three and maximum of seven trustees will be there.

(6) First trustees :

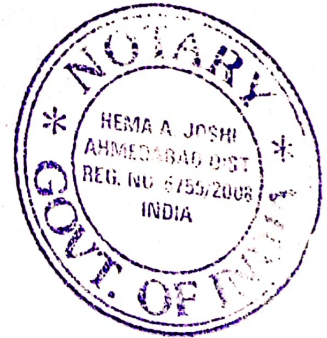

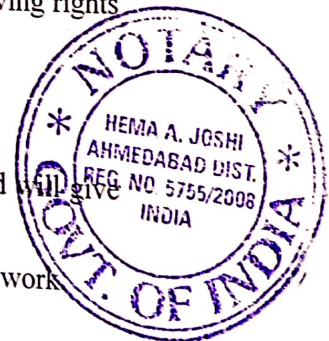
(7) The post which vacated as trustee in trustee committee :-

This trust the present first managing trustees and other first trustees will be the trustee for life time. Unless managing trustee or other trustee



their death, resignation or due to any of reason the post is vacated, than remaining trustees with majority deserving person will be appointed and on such vacated post appointed managing trustee that duration will be for life time. The existing trustees with majority additional trustees can appoint within the maximum strength for deserving persons and by this way appointed trustees their duration will be fore life time. The managing trustee and other trustees their resignation will be sanctioned by remaining trustees with majority.

- (8) For the property of trust : This trust it's movable and immovable properties that will be acquired by the trustees during the time being.
- (9) Managing trustees their powers and duties :
- 1 Will call meeting of managing trustee committee, and in such meeting he will be president and will handle the meeting.
 - 2 If any of time there is equal votes than managing trustee having rights for giving casting vote.
 - 3 Will keep watch over all the act and deeds of the trust, and will give necessary direction and instruction and will do daily routine work.
 - 4 For the work of this trust will appoint employees and their salary, allowances and leaves will be decided.
 - 5 Govt. Semi-Govt. and other firms, office, persons, will represent



candidature ship, and will do all correspondents on behalf of trust.

6 Will give receipt for income of trust, and will collect voucher for expenses.

7 Will keep account of trust income and expenses.

8 In meeting of trustee committee will present account of trust for financial year budget will present and will get sanction from managing committee.

9 will get auditing of trust's account.

10 Will keep record of trust's resolution and will execute the same.

11 Will take action for precaution of trust's properties.

(10) Trustee committee it's duties and powers:

1 During the time being the act and provision which in force accordingly

will do investment of property, can give gift, and can transfer legally.

2 Will do investment of amount as per provisions of law.

3 Will be active to full fill the aims of the trust.

4 This trust it's account and budget by checking the same will take decision of consent.

5 Any of trustee for work of trust if spent amount from self that he can demand from trust and he entitle for the same.

(11) Trustee committee it's meeting and corrum : The trustees can call the trustee committee meeting as they deem fit and proper, and the notice



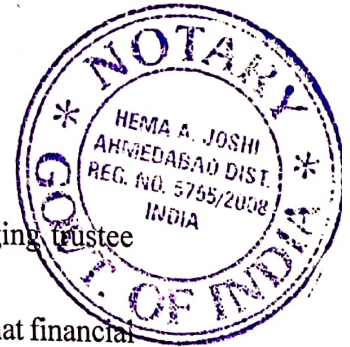
of such meeting will be given to all trustees before seven days. In this notice the date, time and place of meeting and the proposed work that would be mentioned. The corrum of meeting will be considered as completed with presence 3/5 of total strength. Due to corrum pending meeting will held after one hour and will work carried out without corrum.

(12) The sources of income of trust: Donation, gift, fund, contribution , help, by arranging charity show, the income can be covered.

(13) Resolution and Resolution book: In trustee committee the resolution which made that will sanction with majority and will be written in resolution book, and under which managing trustee and other trustees will do their signature. In abnormal situation the resolution can be made by circulating also.

(14) Bank Account :

The bank account will be opened with signature of managing trustee and one other trustee with their joint name being opened and that financial transaction can be made with signature of any of one.



(15) Accounting year :

This trust it's accounting year will be from 1st April to 31 st March

Ending.

(16) Committees :

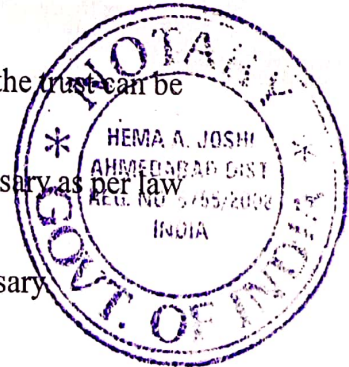
As and when needed the trust committee for work of trust to be helpful the administrator or advise committee like that other committees be appointed and can dissolve also such committees. And in such committee there will be managing trustee will be chair person.

(17) Amendment :

This trust it's trust deed of any of section if any change, addition, to be made than as per Bombay Trust Act 1950 accordingly with consent of majority trustees can be made.

(18) Dissolution :

Bombay Public Trust Act 1950 the provision of the same in any of abnormal situation this trust if be dissolved, or required to be cancelled than in such circumstances the trust property to any of trustee, settler, or donor or any other member or founder of trust will not get but by disposal of all responsibilities of trust of credit-debit after that whatever the movable immovable properties be remained, that arrangement as per the present law in force accordingly this trust having the aims such same aims having to that public trust by handing over to that, the trust can be dissolved or can be closed. And with this respect if necessary as per law the charity commissioner their prior permission is necessary

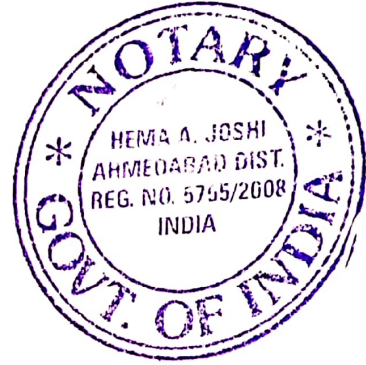
